Information regarding any business not listed, transfer fees, or pro-ration may be obtained from the clerk by calling 599-3550 between 8:00 AM-4:30 PM.

"General Store" in this case shall mean and include any store/mercantile in which goods, wares, or merchandise of any kind is purchased, ordered, sold, be it retail or wholesale, including tobacco or cigarettes.

"Special Store" in this case shall mean and include any store/mercantile in which goods, wares, or merchandise of any kind EXCEPT cigarettes, tobacco, or soft drinks is purchased, ordered, sold, offered for sale, either retail or wholesale AND which contains no coin-operated devices owned or operated by the store proprietor.

All **VENDING MACHINES** (soft drink, gum, cigarette, etc) must be applied for by the proprietor or management at the time the store license is requested.

Applicants for **BEER LICENSE** must have questionnaire including signature and acknowledgement, along with a state beer license to be presented to the business office at the time of application.

Failure to secure a new license before July 1st will make you liable to punishment for operating without a license.
 Failure to apply for a license after July 1st will make you liable to punishment **PLUS** a penalty of ten percent (10%) of the annual fee for each month or fraction thereof delinquent.
