Kevin Sneed State Floodplain management. Current ordinance is out of date and not compliant with current FEMA regulations. Ordinance needs to be updated immediately so that the 9 residents with the floodplain insurance will be able to keep it. Our ordinance will be updated and placed on the agenda for a first reading at the next council meeting.

"WV State code 15-5-20A- requires all cities are required to have a Flood plain manager." Per State Code, "Commencing July 1, 2012, each floodplain manager in the state is required to complete six hours of training in floodplain management annually to maintain good standing with the West Virginia Division of Homeland Security."

Code Inspector Lanie Martisko will be attending the class in Flatwoods to be certified.

TIF Information for Boyers Ave.- Councilor Dominick Claudio attended county commission work session meeting and was informed the town needs to figure out DOH right of way on Boyers Ave, before selling. The County Commission must agree to the proposed land use and the purchaser. No net proceeds over the TIF bonds payoff amount can be kept by the town. Attorney Tom Aman will help with modification plan. Town can use TIF dollars for appraisals and expenses.
